In your local library...

Library concessionary card

If your child has a learning difficulty/ASD, they can have an Access Card from your local library, which entitles them to 2 free audio-visual items free of charge (music CDs, videos, DVDs etc.) and all their audiobooks on tapes or CD are free. Boardmaker software

Boardmaker communication software is a flexible way of creating symbol-based displays, schedules and choice boards. These displays are incredibly useful for support for those on the autistic spectrum or with communication difficulties. You can get free access to the software and staff can offer support to use it. They also offer free printing and laminating. Boardmaker access is available in the following libraries:

Merlin's Magic Wand charity

Merlin's Magic Wand believe in putting the magic back into the childhood of seriously ill, disabled and disadvantaged children by providing free tickets to Merlin attractions (Legoland, Thorpe Park, London Eye etc.) The eligibility criteria is that your child, aged between 2 and 18 years, with a disability or serious illness must either have a Statement of Special Educational Needs or be in receipt of a letter stating their condition in order for you to apply for tickets. Paperwork must be on headed paper which includes the organisations logo from an official source and have the child's full name, the child's date of birth, the child's medical condition or diagnosis or proof of foster care. Family Fund Grants

The Family Fund provides grants to families with disabled children. The Fund will consider any request on its merits but does have specific criteria about claiming. Several people have successfully applied for help with the costs of driving lessons, holidays, a new washing machine or tumble dryer and various other things! Cinema Exhibitors' Association Card

This national card that is awarded to the child/person with a disability, that entitles them to one free ticket for a person accompanying them to the cinema. To be able to apply, the cardholder must have proof of one of the following criteria:

- Be in receipt of Disability Living Allowance
- Be in receipt of Personal Independence Payment
- Be a registered blind person



You will need to complete a form (this can be done online at the CEA website or you can print a copy out and post it to them), you will also need a passport sized photo and a proof of entitlement document. The card costs £6 and is valid for 1 year.

Radar Keys for disabled toilets

The National Key Scheme offers independent access by disabled people to around 7,000 locked public toilets around the UK.

If your child has a disability, you are entitled to use these toilets or if your older child is still in nappies or doesn't get much notice that they need the toilet and cannot wait in a queue.

They are available free of charge from your local council offices (you usually need to complete a form with all your details on it) if you have a diagnosis letter to show your child is entitled, or you can purchase one from The-Zone! for just £2.50 (this is great if you need a second key for another carer). Just ask us at any of The -Zone! sessions.

Travelling safely!

We know that getting from A to B is never a simple thing, but here's a few things we've learned the hard way so you don't have to!

Special needs car seats

Britax Traveller Plus car seat is ideal for older children with special needs and suitable for children from 4 - 11 years (15 - 36 kgs). This seat is strapped into the car and then the child is strapped in with the 5 point harness and additional clip between the chest straps. Costing around £600. This will not contain a child determined to escape though. Available from various websites but here's one to get you started: www.incarsafetycentre.co.uk/product/traveller-plus or call them on 01908 220909.



Cybex car seats are also another route you could try - these car seat don't have a 5-point harness, but instead have an adjustable safety cushion. Suitable from 9 months to 11yrs and costing around £260. Might be worth looking into if the harness is part of the battle but we haven't heard how these fare with our escape artists. Crelling harnesses and reins

Crelling sell "Houdini" harnesses which are made to contain children and adults whose challenging behaviour requires a certain degree of restraint. These have been used by several The-Zone! families and indeed Hampshire County Council use them on some school transport runs. The harnesses fasten around the seat in the car and make it practically impossible for the child to escape!

They also sell walking reins for older children and adults and harnesses that can be used to contain a child safely within their pushchair.

Additional ideas:

Chest strap clip - these can easily be bought and attached to the child's current car seat with a 5-point harness. They aim to deter your child from wriggling their arms free from the straps.

Buckle covers - these are designed to cover up the release button to stop little fingers undoing the main seat belt fastener.

BeltUpp - this is an additional strap designed to keep your child in place and upright in their group 2 car seat. These cost £17.99 and are available from www.beltupp.com

Special needs pushchairs

Maclaren Major buggy is an umbrella fold stroller that is suitable for older/larger children, up to the weight limit of 50kg/110lbs. The basic buggy and footplate costs £239 (0% VAT - see below for more info) inc free delivery - or take a look at the other packages available if you want accessories too. There is also now a vest harness, to try to help contain escapees.

** 0% VAT : If you buy a pushchair for a child who needs it due to a medical condition, then you don't usually have to pay VAT. VAT relief is not just available for a child with a physical disability who is unable to walk, in fact most children in this situation would be eligible for equipment from the NHS, free! **

Ottobock Eco Buggy

If you need a pushchair for an older child, that still reclines, then the Ottobock Eco Buggy may be more suitable for your needs. It costs £400+ and more info is available at:

Dentists

If your child has special needs (including autism, learning difficulties, challenging behaviour etc) and they cannot cope with seeing an ordinary dentist, then you should be able to self-refer to the Solent NHS Trust to access the Special Care Dentistry Team. In order to access this service, you must be registered with a Hampshire GP.

You will need to contact the team on 023 8069 8677 or e-mail SNHS.CentralPointofReferral@nhs.net to request a referral form.



Teeth cleaning!

If teeth cleaning has become a battle, then here are some of the things other families have tried: using a variety of different toothbrushes; ones that light up, sparkle with glitter, electric ones that vibrate, musical ones or even the ones you place on the child's fingertip! Has anyone tried the Collis Curve toothbrush? www.colliscurve.co.uk it's an interesting design and seems to get good results!

Try using a timer to help show your child how long they need to keep going for; sand timer, digital timer, the coloured oil timers, anything that keeps the cleaning going for longer than 10 seconds!



As for toothpaste - try different brands, flavours, types;

we've heard good things about OraNurse - a flavourless, non-foaming toothpaste! www.oranurse.co.uk

What have you discovered that works?



For the sensory chewers

If you have a "chewer", be it their sleeves, fingers, random bits of tissue, paper or anything else they take a liking to, then it may be worth trying to find an alternative...

Chewigem - make all sorts of items from pendants, toggle tags, bangles; all designed to be chewed! Take a look at www.chewigem.co.uk

ChewyTubes - tubes and P's & Q's designed to cope with lots of chewing: www.chewytubes.com

Chew'lery - a necklace and bracelet that's made to be chomped upon, available from various websites, including www.specialdirect.com

Auto retract keyrings - these are a great way of keeping fidget toys or chew toys easily accessible but out of the way when they're not needed. These are available on Ebay for a reasonable cost.



Breakdown Service

With most breakdown services (the AA, RAC, Green Flag etc.) if you are a member and you tell them that you have your disabled child/adult in the car when you ring for assistance, they will make your call out a priority!

Road tax

If you are in receipt of the Higher Rate Mobility component of the Disability Living Allowance then you can apply for a road tax exemption certificate. You may have been automatically sent an application form for a Vehicle Excise Duty (VED) exemption certificate with the DLA award letter. Disability Living Allowance

- things we've learnt over the years!

Disability Living Allowance (DLA) is paid at different rates depending on how the disability affects your child/young person.

Rate	Care component	Mobility component
Higher rate	£81.30 a week	£56.75 a week
Middle rate	£54.45 a week	N/A
Lower rate	£21.55 a week	£21.55 a week

DLA has 2 parts called "components":

- care component: if your child need more supervision or help to look after themselves than their peers.
- mobility component: if your child can't walk or finds it very hard to walk, or get from A to B safely, in a reasonable time.

You could get a combination of both, or just one of the components.

Getting started:

The first step is to call and request a DLA claim pack 0845 712 3456. The form will be dated and give you six weeks to return it to them - if your claim is successful, they will then pay you from the date you requested the pack. It is possible to download the form at www.gov.uk/disability-living-allowance-children save it and complete it on your computer.

Make notes:

Sometimes it can help to keep a diary over a few days, detailing everything you do for your child - this can be quite an opener sometimes! As well as any incidents or meltdowns and what you had to do to calm the situation.

Use a draft copy or blank sheets of paper to work out what you want to write for each page.

If you need help with completing the form:

It's always good to go through the forms and complete the basics; your child's details, your details, bank information etc. Then work on the sections that you can; diagnoses from hospital letters, medication details, information from reports. Next tackle the questions, one at a time - you can always come back to a page and add more later. Once you have done your best, ask for help - get in touch with us, or whoever else you have found, to read through your completed form and see if add anything else crucial to it!

DLA: Severe Mental Impairment & disruptive behaviour

Severe mental impairment (SMI) refers to a child who 'has arrested or incomplete physical development of the brain resulting in severe impairment of intelligence and social functioning'.

The disruptive behaviour must be extreme, require physical restraint to prevent physical injury or damage to property and also require someone to watch over your child whenever they are awake.

Severe impairment of intelligence is determined in many ways. It can be through an IQ test or by assessing someone's 'useful intelligence' - the ability to function in a real-life context.

As a rule, if your child is in a mainstream school, this won't be relevant but may well be if they attend a complex learning difficulties school.

Useful tips for DLA forms:

- ⇒ If you need more space, then write on extra sheets of paper and staple it to the form (make sure you also write your child's name, DoB and NI number each sheet too, just in case they become separated.)
- ⇒ Aids used can include PECS/visual schedules/prompts but always emphasise that you still have to encourage/reward/assist with the aids.
- ⇒ Time/issues in education don't always count unless your child has the same issues at home.
- ⇒ Send any additional evidence; paperwork from school, IEP's, reports etc. BUT make sure what you are sending supports what you are putting on your form!
- ⇒ If including examples, compare to a child of the same age without any difficulties.
- ⇒ Day time = 7am - 11pm
Night time = 11pm - 7am

Before you send the form back:

Always make sure you keep a copy; whether it's saved on your computer, photocopied or even use your phone to take a photo of each page - it means if it gets lost, you have a copy and when it comes to renewing your claim, you know what you put last time.

(If you need to go down the route of appealing a decision, do not worry, they will send you a copy of all of the evidence, including your completed form, on which they based their decision.)

Decision letter:

If you receive a decision that you are happy with - well done and we hope that it has a nice long date on it until you have to renew! Don't forget to see if you are entitled to claim any other benefits now too: perhaps Carer's Allowance, and it can increase your Child Tax Credits too. If you have been turned down or you aren't happy with the rates your child has been awarded, then the first step is to pick up the phone and talk to the DWP. They will arrange for another assessor to go through all the paperwork and reconsider your application. They will then notify you of that decision.

If you are still not happy, you can then appeal it; they will arrange a hearing for you to attend (it's usually better to do this without your child attending, unless you honestly think that the panel would benefit from meeting the child face to face). Although it is a more informal environment, it is still a legal procedure and therefore the panel is made up of a legal official, a medical expert (be it a paediatrician, GP or another professional) and usually a parent/carer representative. Do not be intimidated, just answer their questions honestly.

All of this can take time, but if you are successful, the payment will be backdated to when you began the whole process!

Education, Health & Care Plans (EHCP's)

From 1st September 2014, changes to the SEN law with the implementation of Part 3 of the Children and Families Act 2014 mean that the new Education Health and Care Plans (also known as EHC Plans or EHCP's) will replace Statement of Special Educational Needs and post-16 Learning Difficulties Assessment (LDA) (section 139a/Moving On Plan).

If you apply for additional support for your child from September 2014 onwards, you will follow the EHCP process.

An EHCP is for those aged 0 - 25 years who need more support than the school are able to provide from within their own budget. It will require the education department, health authority and social care department to all work together to meet a child's needs. Personal budgets and direct payments can also be incorporated, but the funding for these still isn't great, so you'll need to be realistic with what you expect to get from them.

Families should be actively involved in completing an EHCP, indeed the "Our Story" section is for parents to complete with what they think needs to be included - make your words count!

The process...

Request for assessment

An EHC needs assessment can be requested by you, the school or college, or by a young person over the age of 16 but under the age of 25. Anyone else can also bring a child or young person who has, or may have, SEN to the attention of the local authority.

Proposal to assess

As soon as the request is received, a letter will be sent to you outlining the assessment process. There is a period of 25 days for you to send in comments on the proposal to assess. Within 6 weeks the local authority will decide whether or not to proceed with the assessment and inform you by letter of the decision and the reasons for it.

If the LA decide not to carry out an assessment you will have the right of appeal to the First-tier Tribunal (SEN and Disability).

EHC needs assessment

The local authority will seek advice and information from the following:

- Parents (in addition to your comments you can add any independent written advice you have.)
- Your child
- Early years setting, school or college (headteacher/principal, SENCo and teachers)
- Health care professional
- Educational psychologist
- Social care
- Any other relevant people (eg specialist teacher adviser, speech and language therapist, physiotherapist, occupational therapist etc)

You can attend any examination or assessment of your child.

The assessment should take no more than 20 weeks to complete.

Once all of the advice and comments have been collected about your child's special educational needs, the local authority will decide whether to write an EHC plan for your child. This provides a detailed guide to your child's special educational needs, the educational provision and other arrangements needed to meet them.

Before a final EHC plan is written, the LA will send you a draft EHC plan and explain how you can give your views on it before the document is finalised. You will also need to consider which education setting you wish to nominate for your child. You have 15 days to comment on all parts of the draft EHC plan, but you can ask for a meeting with the local authority to discuss the draft EHC plan which then gives you a further 15 days after this meeting to send in any comments you have.

Parent Voice - Independent Support services

How to make a complaint

If you are not happy with the service you receive from Hampshire County Council, either through social care or the education department, there is a complaints procedure you can follow.

Social Care includes:

- Assessment of children and families' needs
- Family support
- Caring for a child with special needs

Education includes:

- Special Educational Needs (SEN) - assessment and support for parents (the Parent Partnership service)
- The educational psychology, welfare & behaviour support services
- Education other than at school, for pupils unable to attend school

The first thing to do is to raise the issue with a member of staff regarding the issue, or the manager if you prefer.

It is a good idea to put your complaint in writing; this avoids issues being missed or misunderstood.

There are 3 stages of the process, from raising the issue and it can be a drawn out process (even with their timescales to adhere to) but if you believe that things need to change then go for it and don't give up!
